

CARDINHAM PARISH COUNCIL

MINUTES OF COUNCIL MEETING

Held at Cardinham Parish Hall on Tuesday 17th January 2017

Present: Councillors J Best, P Tucker, K Morris, S. Smart, P Claridge, T Irwin, M Ridgewell, County Cllr C Batters. There were 8 members of the public present.

County Councillor

Councillor Batters gave his report. Items raised included:

- Footpath 504/11/4 This matter has now been resolved. The enforcement officer has been out there and the path is back to what it should be.
- Land at Brimstone Hill – decision was taken to appeal and the inspectorate overthrew the appeal.
- Hunting gates – highways have never agreed that they are responsible for the fencing on highways. Awaiting a reply regarding these gates.
- Outside the school – the road outside is bad – due to the utilities digging up the road. Cllr Batters has contacted Highways about the state of this road.
- Venn Cross to Hole – there is a pothole here that is very large and dangerous – has already been reported.
- Cllr Batters confirmed that the £392 grant funding application has been signed off. He also congratulated the Parish Council on this Defibrillator Awareness project and said that Cornwall Council had been made aware of it.
- Regarding planning applications, Cllr Smart said it would be helpful if the planning officer was able to provide guidance on any applications of a more complex or controversial nature.

Public Session

The following points were mentioned

- Footbridge by Stockdales – there is a notice on it to say it will be repaired.
- The bad state of repair of the road by the school serves to slow the traffic down as some drivers do tend to drive too fast through the village.

PA16/12045 Mr L Sharpe, Land North West of Woodhall, Brimstone Hill Cardinham. Proposed conversion/change of use of redundant stables building, to form a dwelling with new rear extension. Cllr S Smart proposed and Cllr P Tucker seconded: The Cardinham Parish Council agrees with this application in principle subject to the planning officer's decision. The Council's

concerns are that the footprint is bigger than the original and the structural underpinning required due to the steepness of the slope on site.
