MINUTES OF ANNUAL GENERAL MEETING

56 / 13 Finance

A review of the Receipts and Payments for the year ending March 31st 2013 had been circulated and the Clerk gave details of transactions during the year and answered questions on the accounts. The audited accounts were being prepared by the accountant and should be available at the next meeting. From discussions it was proposed by Cllr T Keat, seconded by Cllr G Tucker that Cardinham Parish Hall be approached with the suggestion that the rental for meetings be paid on a quarterly or annual basis. **Action taken.**

The Clerk circulated to members of Council the Income & Expenditure statement for

the month ending May 21st 2013. It was then proposed by Councillor G Rogers, seconded by Councillor T Keat to accept the financial report and make the relevant payments of 5 cheques amounting to £1407.13p. All in favour.

The Clerk stated that the Council then should make a decision on Section 137 grant applications. There were only 2, Victim Support and Cornwall Air Ambulance and a proposal of £100 per organisation was defeated by an amendment for £150 to each organisation. (**Action taken Cheque numbers 0663 & 0664**).

It was also noted that the price of the hire of the Parish Hall had increased by £1 to £16 and it was agreed to approach the Hall committee to make an annual payment to cover the costing to avoid the problem of cheques being mislaid and not cleared which had happened on a number of occasions over recent years.

Cllr G Tucker spoke of the lack of maintenance and poor condition of the fencing that had been installed by Cornwall Council Highways Department in the Treslea downs, Higher Mount and Mount Pleasant area. It was suggested that the Clerk contact the Highways Dept, Mrs P Phillips (Warleggan) and Mr J Heap of the Commoners about this matter. **Action taken**.
