MINUTES OF COUNCIL MEETING

held at Cardinham Parish Hall on Tuesday August 20th 2013.

88 /13 Public Session

County Councillor

A further report gave details of some burglaries of sheds and outbuildings in the Lanhydrock area, where reports of a suspicious 'white transit van' had been seen around the same time.
