25 /13 Public Session

County Councillor

In County Councillor M Martin's absence the Clerk referred the monthly report that had been circulated to councillors.

Police

The Clerk read correspondence from PCSO Lloyd Paynter stating that PC 4517 Laurie O'Toole had been placed on temporary attachment to Bodmin Neighbourhood Team(Rural) for a short period and a new Inspector , Robin Hogg has also been appointed. On a personal note PCSO Paynter had become a grandad for the first time and was on extended leave until the end of the month.

It was hoped by Councillors that some of this personnel would be attending council meetings in the future.

26 / 13 Apologies

27/ 13 Declaration of Interest

Councillor G Tucker wished to declare an interest in agenda item 7 (Finance).

28 / 13 Minutes of Previous Meeting.

29 / 13 Matters Arising.

The Clerk stated that most items would be covered in later agenda items.
 Min 13/13 The Clerk had received a reply from the police to the concerns that an incident at Park Farm had not been included in recorded crimes. It stated that the reason was the property in question falls within a different Beat code to that of Cardinham i.e Mount Parish and the police report for the Mount area would be delivered by Liskeard Police. Councillors were surprised at this response and asked the Clerk to follow up this matter.

Min 22/13 After a great deal of correspondence and chasing up the materials for repair of stiles/gates on the footpaths had arrived.

30 / 13 Correspondence

- (i) Zurich Insurance insurance cover quotation required a list of the Parish Council's assets.
- (ii) Notice that Cornwall Council were looking for representatives for the Standards Committee.
- (iii) The Clerk then referred to a new census data available on every Parish within the County. www.cornwall.gov.uk/intelligence. It showed that the 2011 census indicated the usual resident population was 623 in 291 dwellings with a black/ethnic minority of 6 and 98 with Cornish national identity.

31 / 13 Finance

The Clerk circulated to members of Council the Income & Expenditure statement for the month ending February 19th 2013. It was then proposed by Councillor G Rogers, seconded by Councillor P Crier to accept the financial report and make the relevant payments of 3 cheques amounting to £502.02p. All in favour.

The Clerk stated that as from April HMRC is imposing a new compulsory online reporting system which will require an expensive computer programme. It was agreed that he could approach accountants for a price to complete this work.
