MINUTES OF COUNCIL MEETING

held at Cardinham Parish Hall on Tuesday March 18th 2014.

Present: Councillor Mrs J Best,(Chairman), Councillors: M Frost, S Haynes, Mrs T Irwin, T Keat, S Smart, G Tucker, P. Tucker, County Councillor C Batters and Parish Clerk D Stevens.

The Chairman, Mrs J Best welcomed everyone in particular the new PCSO Linda Thomas and there were 4 members of the public present.

34 /14 Public Session

Public

Mr Bonker read from correspondence from Leonardo Gubert, Senior Ecologist with EM Highway Services Ltd explaining the purpose of the planting new tree saplings on the westbound side of the A30 between the Cardinham airfield – Lidcutt junction stating that it was contributing to the Cornwall Biodiversity Action plan and the ecological impact associated with the future widening of the A30 to the west of the site. Also the area is known to support a hazel dormouse population, a European protected species that is expected to benefit from the new habitat connectivity and food source.

Mr Bonker also enquired about a supply of tree saplings that had been delivered in the school field and made comments questioning some of the content plus the necessity to have the Parish survey.

County Councillor

County Councillor C Batters reported on work on a number of culverts being replaced within the area and also work being completed on the road surface near to Galgeth Farm.

He continued by giving information on the progress of the local input report of the A30 road improvement

Police.

PCSO Linda Thomas introduced herself to the Council giving a brief outline of her experience in the role and he hoped that she would be able to work closely with the community, getting to know individuals and primarily focus on crime prevention in the area. She highlighted the issues prevalent e.g. boy racers, bikes on the commons and animal welfare. She continued by clearly giving a detailed explanation of the difference between a crime and a logged incident, agreeing that she hoped in the future to also include in the monthly report details of logged incidents.

The current report showed crime figures in the Parish for February: 1 Burglary and 2x Possession of drugs.

After some discussion it was agreed to delay the payment to Cumbrian Clock Company amounting to £171.60p until the Clerk had contacted them asking for clarification on the lateness in contacting Council representative on date of their visit, reason for wrong setting of clock and promised service report.
