MINUTES OF COUNCIL MEETING

held at Cardinham Parish Hall on Tuesday November 21st 2014.

Present: In the absence of the Chairman Cllr Mrs J Best it was agreed that the Vice Chairman Councillor G Tucker took the Chair. Councillors: M Frost, S Haynes, Mrs T Irwin, T Keat, M Martin, P. Tucker, County Cllr C Batters.

In the absence of the Clerk on holiday, a former Acting Clerk Mrs Rosemary Rowe kindly agreed to take notes for the meeting.

Cllr G Tucker explained that the Chairman, Mrs J Best was still not well and the best wishes of the meeting were sent to her.

155 /14 Public Session

Mrs P Bonker stated it was good to see that the back of the churchyard had been cleared and asked if something could be done to trim/clear the self seeded trees that had grown in the area.

Mr Bonker on the modification of the order of Bridle Path no 2 stating that following consultation with Cornwall Council footpath representative it looks as if a favourable report will be received.

Also after work by SW Water to unblock the sewer connection today it is hoped the recent obnoxious smell will stop.

County Councillor

County Councillor C Batters then gave his report that included work he was completing :

- Individual matters with people in the Parish.
- Trees at Bunny's Hill seems to be common land Cornwall Council following up on this matter. Top area owned by a couple from Camelford.
- He had sent photographs of trees at Treslea Cross to Cornwall Council.
- Cost of salt bins £143 incl VAT, 1 tonne of salt £93.63.

Cllr M Martin asked if the County Councillor could provide any information on the recent sudden resignation of the Council Cabinet representative for finance. County Councillor Batters was unable to respond and asked permission to then leave the meeting.
