

CARDINHAM PARISH COUNCIL

MINUTES OF COUNCIL MEETING

Held at Cardinham Parish Hall on Tuesday 20th September 2016

Present: Councillors J Best, G Tucker, P Tucker, S Smart, T Keat, K Morris, P Claridge. County Cllr C Batters. There were 7 members of the public present.

County Councillor

Councillor Batters gave his report. Items raised included:

Missed waste collections

Potholes on Froxford Hill

Hedge cutting in Millpool with waste left in the road

The Planning application PA16/04581 IS to be considered at committee meeting – Cllr G Tucker will attend the East Planning Committee meeting to put the Parish Council's view on this planning application.

Hedge cutting – query raised as to who will pay for the hedge cutting. Cllr Batters confirmed that if notice has been served and the owner doesn't cut the hedge, and Cornwall Council then have to cut it, the owner will receive the bill.

Cllr Smart queried recycling procedures now the incinerator is working. Cllr Batters confirmed all rubbish will go to the St Dennis incinerator and there will be no more landfill.

Further comments were made regarding the incinerator and, as it became more heated, the Chair stepped in to bring the discussion to a close.

Public Session

Francis and Natasha Clark attended the meeting in order to let the Parish Council know about their forthcoming planning application. The Chair welcomed them to the meeting and thanked them for attending.

Mr Bonker raised the issue of the colony of feral cats. He then went on to mention the Local Maintenance Partnership and asked if it would be put up for tender. He asked if the schedule is to go on the website. He queried the wording of minutes.

Mrs Hanbury-Tenison explained that the planning application was for a smaller scale plan.

Dualling the A30

Mr Martin gave an update on the A30 Dualling. This has now been changed back to single lanes, now the holiday season is over.

178/16 Declaration of Interest

Cllr G Tucker declared an interest in the section on LMP. Cllr T Keat declared an interest in planning application PA16/06487.

179/16 Minutes of the Previous Meeting of 16th August 2016

The minutes of the previous meetings held on 19th August 2016 had been circulated. These were proposed by Cllr P Tucker and seconded by Cllr K Morris, as a true record of the meeting then signed by the Chair. Cllr P Claridge abstained.

180/16 Matters Arising

- The west gate of the churchyard: Cllr G Tucker had looked at this area and reported that there were no steps remaining and the gate had disappeared. Await reply to our earlier letter from Church Warden.

182/16 Local Maintenance Partnership

Cllr J Best described what the Local Maintenance Partnership entailed. The schedule listing the paths, and which also included the amount of funding available for each path maintained, was passed to Cllr G Tucker who is currently the contractor maintaining the footpaths in the Parish. The Footpath subcommittee will meet and discuss/ update the schedule and the information can then be forwarded to the relevant dept at Cornwall Council. Clerk to request map as a pdf.

183/16 Footpaths

Footpath marking:

- Require at least 2 marker posts for the parish footpaths.
- One farmer in the parish has had problems with people not knowing the route to take across his land so he has put in a granite post – a good idea which has helped.
- Dog mess is a problem. Clerk to request some signs.
- Notification received that the footpath by the river has been diverted. Cllr G Tucker will investigate and report back.

Cllrs J Best and G Tucker declared their interest in the next item and left the room.

184/16 The Letter from Miss Ella Bate re a donation: to consider if it is acceptable to make the cheque payable to the Parish Hall.

Cllr P Tucker took the chair. Miss Bate had left a donation of £500 but the wording said it was to be paid to the trustees of the Parish Hall. This wording was an error as the intention was to pay this to the Parish Hall. Mr Steve Best had explained this. Cllr S Smart proposed and Cllr P Tucker seconded that the Parish Council acknowledge that this donation should go to the Parish Hall. Majority in favour.

185/16 Finance Report and Payment of Accounts

- PA16/06487. Mr David Stockman and Mrs Angela Stockman Land North of La Hayes Cottage, Cardinham, Bodmin. Construction of an agricultural extension adjoining a previously approved (PA14/02188) livestock/forage, machinery storage shed. Cllr S Smart proposed, Cllr P Claridge seconded to support. Majority in favour.
- PA16/07429. Mr Nigel Pollard, Lower Treslea Farm, Cardinham, Bodmin. Formation of a new doorway to the external wall of the dining room and construction of a garden room extension. Cllr G Tucker proposed and Cllr S Smart seconded to support. Majority in favour.

Cllr G Tucker declared an interest and left the room.

- PA16/07976 Mr M Hanbury-Tenison Cabilla Manor, Cardinham, Bodmin. Proposed construction of ancillary accommodation for applicant's parents and additional bed and breakfast accommodation together with ancillary works. Cllr S Smart proposed and Cllr P Claridge seconded to support. With the following conditions: footpath to remain; building shouldn't be separate from Cabilla Manor house. Majority in favour.

Cllr Batters left the meeting. Cllr G Tucker returned to the meeting. Cllrs J Best and K Morris declared their interest in the following item and left the room.

- PA16/08481 Mr and Mrs Bilkey Newlyn Barn, Chapel Lane, Millpool, Conversion of barn into 1 bedroom self contained holiday let. Cllr S Smart proposed and Cllr P Claridge seconded to support. Majority in favour.

Cllrs J Best and K Morris returned to the meeting.
