

CARDINHAM PARISH COUNCIL

MINUTES OF COUNCIL MEETING

Held at Cardinham Parish Hall on Tuesday 20th February 2018

Present: Councillors J Best, G Tucker, K Morris, P Claridge, M Ridgewell, T Irwin, S Smart, P Tucker, G Rogers. County Cllr C Batters. There were 7 members of the public present.

County Councillor

Councillor Batters went through the issues raised in his monthly report for January/February. He had dealt with the following issues:

- Cardeast Farmhouse – road conditions reported
- Gritting on Bunny's Hill – not high priority for Cornwall Council
- Bridlepath No2 – to be covered under public participation.
- Electoral/boundary review to include the Northern part of Bodmin, plus Bodmin West and the rural parishes of the Lanivet and Blisland ward apart from Lanhdyrock.
- Potholes that were reported ~~have all been repaired~~ should have a turnaround period (inspected and prioritised) within 72 hours of being reported.
- Requested that in bad weather could one route be gritted so at least there was one route in and out.
- The Bike Trail is still a proposal only.

Public Session

Issues raised:

- Millpool signage and the fact that there is currently no signage on the A30 for Millpool, but there are several signs for Cardinham.
- It was noted that the signage comes under the remit of Highways England – Cardinham PC to ask County Councillor to put pressure on Highways England to: a) amend the signage on A30 to show Millpool b) preferred route into Cardinham should be the Airfield road and signage should reflect this.
- Bridleway no2 – finished apart from drainage and is now suitable for horses.
- Footpath 24 – closed due to the bridge and erosion of the bank
- A large tree has fallen across but this will be cleared once the weather improves
- issue of passing places on the Airfield Road
-Cardinham PC to request funding from County Councillor for signage for the passing places

Cllr Batters then left the meeting

- The agent for Callybarrett had attended – new access, no visual impact, highways Had commented that they had no concerns and there have been no objections to date.

annexe/holiday accommodation. Cllr S Smart proposed support. No Seconder. Cllr P Tucker proposed objection and Cllr M Ridgewell seconded on the grounds that the proposed construction would be a significantly bigger footprint than the original that is being replaced. One abstention, majority in favour of refusal.

- PA18/00498 Mr L Sharpe, Land North West of Woodhall Brimstone Hill, Cardinham. Non-material amendment for additional bedroom instead of integral garage, change garage door to window. Proposed conversion/change of use of a redundant stables building to form a dwelling with new rear extension. Already decided.
- PA18/00596 Miss Sue Tarry, Land North East of Dreason Cottages, Lostwithiel. 1 no. storage and distribution unit (B8 use), together with associated works. Cllr P Tucker proposed support, seconded by Cllr G Tucker. All in favour.
