055/19 Minutes of the Previous Meeting 19th March 2019

056/19 Matters Arising

Cllr S Smart suggested that Norman Trebilcock or Alan should be the people to contact regarding the green light. Not flashing on the defibrillator when in use. Clerk to contact them.

Highways matters – the trench opposite the playing field 50m long, 1m wide 9inches deep.

Cllr G Tucker raised the matter of what happens to the recycling.

Cllr G Rogers had contacted Cornwall Council re the Biffa lorry leaving trails of rubbish behind ie fly tipping.

060/19 Finance Report and Payment of Accounts

The Chair then announced the exciting news that the Parish Council's bid for funding from the Callybarrett Wind Turbine Community Benefit Fund had been successful. The Chair thanked the group's representative, Mrs Charlotte Matthews for the generous contribution of £2226.39 which will be used for the defibrillator project in the Parish. This project to be completed before 30th April 2020.

063/19 Defibrillator

It was suggested that Mr N Trebilcock/ Duchy Defibrillators would be able to help re checking if the green light should flash when the defibrillator is in use, and also, to query if anyone physically checks the Cardinham defibrillator cabinet as part of the maintenance contract. Clerk to contact Alan at Duchy Defibrillators. Also, to let them know that we will be starting the Millpool part of the project shortly as we have now secured partial funding.

064/19 Footpaths

A stile, by Treslea, has been reported as being in a dangerous state. Cllr G Tucker will go and inspect it and contact Cornwall Council if required.

065/19 Highways

Correspondence from parishioner regarding traffic by the preschool has been forwarded to the school and to the County Councillor.

Update on the Highways schemes – Cllr Claridge attended the Network Panel meeting and reported back that the Panel has now agreed to support the Cardinham scheme for signage/Slow Signs to be painted on the roads in appropriate places in the Parish. Also that Highways will look into whether anything can be done regarding the sharp and narrow bend on Millpool slip road.

Trenches – the trench in the area outside the preschool needs attention. Also one by Rempstone in Little Downs, and one in the dip after Rempstone heading East. Clerk to contact Highways and arrange for them to meet Cllr Tucker who will show them the Highways issues within the Parish.

066/19 Tourist Information Hub

The Bus Shelter has been vandalised with a fire. It requires repainting. It was agreed that anyone available to help will meet on Thursday afternoon. There is some paint left from last time, Chair to obtain more if necessary. Clerk to obtain Tourist information sign and no smoking sign.

067/19 Community Network Area SOS Launch.

068/19 Repositioning the Memorial Stone.

069/19 Cemetery/Churchyard.

The Cemetery committee met with Mr Searle on 27th April. Mr Searle made an offer to provide stone and labour. The Parish Council has stated that at present it can not agree to any works as it needs to check Cornwall Council's archived records, which are currently unable to be accessed until September. Reply to Mr Searle confirming his offer was read out at the meeting and that no further can be taken until records can be accessed.

070/19 Parish Matters

Cllr Smart relayed the information regarding parishioner stranded on the Moor, fortunately being rescued.

Be aware that break-ins in the Parish are still happening so people are advised to be vigilant. It has been reported to the Parish Council that there are some issues with people accessing the school playing field with dogs/out of hours. However, this is a matter for the school so any issues should be reported to them.

There has been flooding on the road at the junction of Long Downs. Area needs clearing of mud again.

It was suggested that the Parish should hold the Beat the Bounds event in 2020. This event requires police involvement. Usually held March/April time.

Annual meeting – speakers that will be attending are the Police Cyber Crime Officer, to talk on Cyber Crime, and representative from the Good Companions to talk about Climate Change.
