Routine maintenance is gradually getting underway again. Gullies have been cleared at Brighton Water, but the cattle grid at Foredowns still needs clearing out.

Submission of details to discharge Condition 3B, 3C and 3D (Archaeology) of Decision Notice PA18/07725. Cllr G Rogers proposed support, Cllr G tucker seconded all in favour.

054/20 Finance reports and payment of accounts

055/20 Footpaths

Cllr G Tucker gave a brief update on footpath 17 and 12, and bridleway 2. Footpath 17 is still flooded. Bridleway 2 had been reported as starting to get overgrown so Cllr G Tucker will investigate and clear if needed. Footpath 12 (Puggy Lane) has been levelled - a manhole cover has been installed – Cllr Tucker will check what this is for.

056/20 Highways

- Cllr L Sutton raised the issue of speeding traffic in Millpool and asked if it would be possible to have the white lines in the road at the start of the 30mph zone, as in Mount, to try and encourage drivers to reduce their speed as they enter the village. Clerk to contact Highways.
- Cllr G Tucker suggested having the rumble strip, which was also one of the measures added in Mount.

058/20 Zoom subscription

Discussion on whether or not to go for the Zoom subscription at around £11.99pm.
