MINUTES OF VIRTUAL COUNCIL MEETING

Held via Zoom on Tuesday 30th June 2020

Present: Councillors J Best, G Tucker, G Rogers, P Tucker, P Claridge, P Fleming, K Morris, L Sutton, County Cllr C Batters and 2 members of the public.

The Chair welcomed everyone to this virtual meeting, the first for our Parish Council.

Public Session:

Issues raised were

- Planning application PA20/04419. Points were raised by one parishioner, who was neither in favour nor against the application. The applicant then provided answers for each of the points raised.

035/20 Cornwall Councillor

The issue of the gates was raised, and it was noted that this is on the schedule of works to be done. Cllrs G Tucker and L Sutton raised the issue of Puggy Lane which has recently been washed out by heavy rainfall. The Lane had been resurfaced not long ago and the resurface material has ended up all over the road (Highways were called due to dangerous state of the road afterwards) and in people's gardens. Cllr Batters asked that they both give the details to the clerk who can then pass on the details to him. He also mentioned that planning application PA20/0151 had recently been withdrawn.

4. Agree the Certificate of Exemption, adopt and sign: All councillors were provided with a copy of the Certificate of Exemption to check through. Cllr G Tucker proposed and Cllr P Claridge seconded to agree, adopt and sign the Certificate of Exemption for 19/20 as being correct. All in favour

042/20 Footpaths

Cllr G Tucker gave a brief update on the footpaths. He has been keeping them clear throughout the current circumstances. He will contact Cornwall Council regarding Puggy Lane to find out how much has been spent on resurfacing this Lane, as it has now been washed away.

The footpath at Higher Bury was mentioned as this is often flooded. It is affected by water run-off from the Moor so could be difficult to remedy but Cllr G Tucker will report it anyway.

043/20 Highways

- The road by the school has started to crack again and needs attention. Clerk to notify Cormac
- There is a hole on the road just above Treslea cattle grid - this needs looking at urgently as it is in danger of collapsing.
- The Cattle grid at Foredowns needs emptying as it is nearly full.
- At the bottom of Peaches Hill, the surface of the bridge is bad, there are potholes and a build up of gravel. This is very dangerous particularly for motorcycles and should be reported urgently.
- A query was raised regarding the routine maintenance and whether it was being carried out.

Saplings in the Churchyard – Cllr G Tucker will have a look to see if they have been dealt with, and the Chair will contact Lanydrock Garden Services.

046/20 Planning Applications.

Cllr P Fleming declared his interest in the following application and left the meeting.

PA20/04419 Mr P Fleming Cardinham Chapel, Cardinham. Demolition of existing shed and erection of wooden garage to side of existing parking area with associated works.

The councillors had concerns regarding the listed building aspect of this application. Therefore it was proposed that the Parish Council should not send in a formal support or objection but instead rely on the expert knowledge of the environment officers and planning officer in this case, and agree with their decision .
