084/20 Agree to an extension of the 6-month rule for Cllr M Ridgewell.

The Chairman had been in contact with Cllr M Ridgewell to discuss the 6-month attendance rule for meetings and had spoken to him regarding his options for attendance at the virtual meetings. Unfortunately, Cllr Ridgewell has been unable to attend the virtual meetings due to lack of any technical means to connect eg computer/smart phone etc, and therefore, as he has not attended a meeting for 6 months, he has sadly lost his seat. Consequently, the Parish Council was unable to agree an extension. The Parish Council will now advertise the vacancy following the procedures as directed by Cornwall Council Democratic Services dept. Notices are usually provided by Cornwall Council with relevant dates and these will then be put up on the notice boards and on the website.

085/20 Footpaths.

Footpath 30 – Lower Tawna and Footpath 18 need attention – Cllr G Tucker will go and inspect them. He will also carry out trimming where necessary.

Bridleway at Treslea is being monitored

Gypsy Lane (a green lane) - it still in a bad state of repair. It was suggested that this could be maintained by the Footpath dept rather than Highways. This can be looked into.

- Cllr G Tucker reported that the Parish Hall extension is progressing well: floor is finished, cladding is on, 1st fix electrics completed and the plaster boarding has begun.
- There have been ongoing problems with big machinery/farm vehicles coming through the village – vehicles can get held up by cars being parked all along the road from Poundstock Close to the crossroads, and this can prevent some of the large machinery from getting through. Clerk to contact police to see if anything can be done.

- A mattress has been dumped in the layby at Fletchers Bridge. Clerk to report it as fly tipping.
- The chair explained that we have purchased Zoom and now have a monthly subscription so will not be as restricted by time going forward.
- It is intended to go back to holding meetings on the 3rd Tuesday of every month again, these will be virtual meetings held via Zoom.
