### **012/23 Highways**

It was proposed that Grit Bins be put in place at Leball Hill, Fletchersbridge and Peaches Hill. A vote was held. The majority of Councillors were not in favour of providing grit bins at this time. It was suggested that Lanhydrock Garden Services may be able to provide a gritting service for small areas in the parish. Chair to contact them to enquire if this is a service they offer. The following items are to be reported to Highways:

Drains – some drains have been cleared. Top of Millpool near A30 drain needs clearing.

Down by the school and Woodside – water coming out of the manhole.

Treslea cattle grids/Treslea water – water coming out of the cattle grid.

Potholes/road surface at Little Downs is in a bad state and area near where hedge was taken down needs resurfacing

Past the telephone exchange towards Mount, there's a large pothole and edge of road has gone.

Cattle grid gates at 5 ways – latch missing on gate.

Potholes – Lower road from Mount to Little Downs.

Hedges:

Letters to be sent regarding hedges/trees obstructing the highway:

Heatherfield –second letter to be sent.

One other property in Little Downs - owner to be contacted.

Rempstone – field hedges need cutting

Bunnys Hill – lower limbs of trees need cutting.

It was noted that landowners of garden/field/hedges need to cut these back by the end of February. This has been included in the magazine.

### **013/23 Parish Matters**

Gate at Treslea Common needs attention. Clerk to contact owner. Cllr Rogers to provide contact details.

Complaint received regarding shed on land between Pinsla Nursery and Bunnys Hill. Shed is in a dangerous state of repair. Clerk to write to owner.

### **014/23 Finance reports and payment of accounts**

- It was agreed to award the tender for Grass Cutting to Lanhydrock Garden Services Ltd.

The above decision was ratified by the Council. Proposed by Cllr P Claridge, seconded by Cllr G Rogers, all in favour.

**016/23 To Sign off the tender Forms**

Both contractors have provided a copy of their public liability insurance certificate showing cover of £5M therefore the tender forms can be signed off and relevant copies forwarded to each contractor. The forms were signed. Clerk to send to contractors, finalising the tender process.

**017/23 Consider, agree and adopt the final draft of the budget, with any tender information / changes to any of the figures to be included once agreed.**

The final draft of the budget was considered, agreed and adopted with no further amendments. Proposed by Cllr G Tucker, seconded by Cllr P Claridge, all in favour.

**018/23 To finalise and agree precept for 2023/24**

This was considered under Emergency Delegation Procedures and the decision below is to be ratified by the Parish Council:

It was agreed to keep the precept at £10,000 for 2023/24 (eight in favour of £10k, one in favour of an increase, therefore the decision to leave it at £10K was carried)

Proposed by Cllr P Claridge, seconded by Cllr K Morris all in favour that the above decision is ratified.
