

## **CARDINHAM PARISH COUNCIL**

### **MINUTES OF PARISH COUNCIL MEETING**

**Held in Cardinham Parish Hall on Tuesday 21<sup>st</sup> March 2023 at 7:30pm**

**Present:** Cllr J Best (Chair), Cllr G Tucker (Vice-Chair), Cllr A Bonker, Cllr L Sutton, Cllr R Farley, Cllr P Claridge, Cllr R Dyer, County Cllr J Cruse.

#### **038/23 Apologies**

Cllrs K Morris, T Irwin, G Rogers.

#### **039/23 Declaration of Interests**

Cllrs J Best and G Tucker declared their interest in item 10 – Finance.

#### **040/23 Public Session**

- Mr Tyers spoke about planning application PA21/03580. He was concerned that documents are continually being added and that this does not follow Cornwall Council protocol.
- Higher Tawna – a defibrillator is now located in the yard outside the stables there and is available for use ie public access
- Cllr J Best and Cllr A Bonker mentioned that Mr Mike Frost had sadly recently passed away. Mike had been a highly regarded Parish Councillor for Cardinham for many years, and in particular had championed the recording and preserving of the parish footpaths. He had been a valued and supportive friend, especially during some difficult times, and will be greatly missed by many.

#### **041/23 County Councillors Report**

Cllr J Cruse reported on the following issues:

- Foredowns Cattle grid – animals have been crossing the grid.
- Layby's at Airfield Road – Highways have said they have done what they were supposed to. But some of the layby's are not resurfaced yet with tarmac. Nothing else will be done there unless we have a new scheme.
- Health and safety issue at Millpool defibrillator. There is a problem with the drain – there are sand bags there to try and help with the drain issue but this has prevented safe access to the defibrillator. Highways issue.
- Gypsy lane and Treslea issues raised.
- Cornwall Council do not have the 135 gypsy sites that they are supposed to have so this can cause problems
- It was noted that the purpose of enforcement is to uphold planning.

#### **042/23 Minutes of the Previous Meeting held on 21<sup>st</sup> February 2023**
