023/24 County Councillors Report

Cllr Cruse provided her report for this month and covered the following issues:

- Cornwall Council - budget rise of 5%

- Dark Skies – Cllr Cruse asked if Cardinham would be interested in monitoring any new proposal.
- A query was raised regarding as to whether the road from the airfield has been adopted.

The quote had already been accepted at the January meeting. The Chair asked if the collection could be once a month instead. Clerk will enquire but this may not be possible within the contract parameters. Contract will start as from beginning of 24/25.

032/24 Finance reports and payment of accounts

The clerk had prepared a Payments List, Budget to Actual comparison and a bank reconciliation for the current period. These were forwarded to all the Councillors. The clerk posted the cheques to Cllr Tucker and Cllrs G Tucker and P Claridge then signed the cheques, posting on some and returning the Clerk's wages cheque and HMRC cheque. Balance in Community a/c as at 29th February is £21,214.72. CALC previously confirmed that Cllrs G Tucker and P Claridge are able to sign all cheques.

- The Clerk had queried in January when the next routine maintenance was scheduled for Cardinham Parish and received this reply from Highways: "There is no further planned rural maintenance outstanding for this financial year. If there are sites where there is a highway safety concern please advise and we'll arrange a reactive inspection accordingly. Issues can be reported via the Council's highway defect reporting system Report a problem with a road or pavement - Cornwall Council".
- May to August – there will be major roadworks throughout the Parish due to the rollout of fibre broadband by Wildanet.
