

CARDINHAM PARISH COUNCIL MINUTES OF PARISH COUNCIL MEETING

Held in Cardinham Parish Hall on Tuesday 18th March 2025 at 7:30pm

The Chair welcomed Councillors to the meeting.

036/25 Apologies

037/25 Declaration of Interests and Requests for Dispensations

None.

038/25 Public Session

Jackie Greengrass from St. Breward Community Bus spoke about the benefits of the St. Breward Community Bus. Jackie explained how the booking system worked, the different routes the bus took, the various destinations and where the pickup points are. Cardinham parishioners are invited to become a part of this community group and to use the bus. Rates are very reasonable. The timetable for April and May has been provided and will be put up on the Parish noticeboards, as well as being shown on the Cardinham website. The bus is also available to hire at £1.60 a mile. The Cardinham Parish Council would like to thank the St. Breward Community Bus Group for kindly inviting Cardinham parishioners to make use of this excellent community facility.

Cllr John Stanfield from Blisland PC came to speak about the Blisland Community Newsletter and whether Cardinham would be interested in receiving a copy of it, as there are often articles of mutual interest. The Councillors agreed and John has kindly agreed to forward the newsletter to us on a regular basis. This will be sent out to Councillors and will also be included on the Cardinham website. At the CAP meetings it has been mentioned that there are funds to employ a coordinator F/T for a year – if this initiative goes ahead, it could allow the community buses in the area (Lanivet, Blisland, St. Breward, etc.) to be used more effectively.

John also mentioned the Rural Crime Service – PCSO Tom Cornwall holds a surgery for 2hrs once a month in the Blisland shop. Again, this is something that the Cardinham parishioners could benefit from.

The Chair thanked John and Jackie for attending and for providing this very useful information. They then left the meeting.

039/25 County Councillors Report

Cllr J Cruse sent a report that was circulated to all Councillors before the meeting. In the report she mentioned the following issues:

- The Kernow Slide application has been refused. However, the applicant has informed Enforcement he intends to Appeal the decision. He has 6 months to lodge his appeal. She has been informed he is intending to open the operation in the meantime. This is allowed under planning rules.
- The Parish Council agreed that they would make a formal complaint about the handling of this application. It is noted that the active travel study/report shows that this road is one of the quiet lanes mentioned in the report. We note that the slide is now in a different location on the site.

- Cllr Cruse has reported multiple times the litter along the A30, especially around Lanivet, and also the stretch from Cardinham junction to Bodmin. She has also been robustly chasing the litter caused by Highways furniture being left or uncollected from deviations, flooding, and seemingly a multiplication of bollards that keep randomly appearing for no obvious reason. She has also noticed an increase in general litter around the area and picked up 5 cans of Heineken from the layby at Millpool. Cllr Cruse has shared information on how fines can be imposed. Cllr Cruse suggested we should look at putting litter bins in laybys, although the cost of clearing may be an issue. This could be discussed at a later date, if Councillors agree.
